New / Update Registration

A valid registration at the Indian Catholic Community ARGE AAG needs the following requirements:

1. All those members mentioned in the Application Form must be baptized in the Roman Catholic Church;
2. They must belong at the time of the Registration to the Roman Catholic Church;
3. They must be registered members of the Archdiocese of Vienna;
4. They must belong to immigrant Malayalee Catholic Community of Syro Malabar -inclusive Knanaya- Church or Syro Malankara Church or Kerala Latin Church;
5. Members listed in the Application Form must be registered as per Meldenzettel at the Residence of the Applicant;
6. Each married couple needs to be registered separately, even if they reside together at their parental residence or in any other residence.
